1. Election of the President and Vice-President

Mr. Astrit Sulstarova as President of the Polling Board opened the meeting for the election of the President and Vice-President.

Ms. Elizabeth James was elected Vice-President by acclamation.

The chairmanship of the meeting was passed on to the President at this point.

2. Election of the Executive Bureau

Seat N° 5: Mr. Mohamed Chiraz Baly, who was nominated by Ms. Virginie Noblat-Pianta, and elected without opposition.

Seat N° 6: Mr. Jamshid Gaziyeu, who was nominated by Mr. Tensai Asfaw, and elected without opposition.

Seat N°7: Ms. Gloria Nwabuogu, who was nominated by Mr. Baly, and elected without opposition.

3. Election of the Executive Secretary

Mr. Jamshid Gaziyeu nominated **Mr. Ian Richards** for the position of Executive Secretary. Seeing no other nomination, Mr. Richards was thus elected by acclamation.
